

**CONDITIONS OF COMMUNITY CONTROL**

*The conditions of Community Control are specific to your case and are determined by the Judge at sentencing.*

**CONDITION #1** OBEY ALL LOCAL, STATE AND FEDERAL LAWS.

**CONDITION #2** FOLLOW THE GUIDANCE AND INSTRUCTIONS OF YOUR PROBATION OFFICER.

**CONDITION #3** BIDE BY THE RULES AND REGULATIONS OF THE PROBATION DEPARTMENT.

**CONDITION #4** MAKE RESTITUTION IN AN AMOUNT AND AS DIRECTED BY THE PROBATION DEPARTMENT. RESTITUTION IS \$\_\_\_\_\_.

**CONDITION #5** PAY THE COSTS OF THIS ACTION.

**CONDITION #6** OBTAIN DRUG/ALCOHOL COUNSELING AS DIRECTED BY THE PROBATION DEPARTMENT.

**CONDITION #7** UNDERGO PERIODIC, RANDOM DRUG TESTING AT THE DIRECTION OF THE PROBATION DEPARTMENT.

**CONDITION #8** SERVE \_\_\_\_\_ DAYS IN THE WAYNE COUNTY JAIL.

**CONDITION #9** PERFORM \_\_\_\_\_ HOURS OF COMMUNITY SERVICE WORK AS DIRECTED BY THE PROBATION DEPARTMENT.

**CONDITION #10** PAY THE FINE OF \$\_\_\_\_\_.

## **RULES OF PROBATION**

*The Rules of Community Control apply to anyone being supervised by the Wayne County Adult Probation Department.*

**RULE #1** YOU ARE NOT PERMITTED TO LEAVE YOUR RESIDENCE OR YOUR COUNTY OF RESIDENCE FOR MORE THAN 24 HOURS WITHOUT THE PERMISSION OF A PROBATION OFFICER. YOU MUST OBTAIN A TRAVEL PERMIT PRIOR TO LEAVING THE STATE OF OHIO. CURFEW: \_\_\_\_\_ P.M. \_\_\_\_\_ A.M.

**RULE #2** YOU ARE TO MAKE EVERY REASONABLE EFFORT TO OBTAIN AND KEEP LAWFUL EMPLOYMENT APPROVED BY YOUR PROBATION OFFICER. ADVISE YOUR PROBATION OFFICER OF ANY CHANGE IN YOUR EMPLOYMENT STATUS WITHIN THREE (3) DAYS.

**RULE #3** YOU ARE FORBIDDEN TO PURCHASE, OWN, POSSESS, USE OR HAVE UNDER YOUR CONTROL ANY DEADLY WEAPON, FIREARM, AMMUNITION OR DANGEROUS ORDNANCE. AS A FELON, YOU DO NOT HAVE THE PRIVILEGE TO HUNT WITH A FIREARM. YOU MUST GAIN RELIEF FROM DISABILITY AFTER YOUR RELEASE FROM COMMUNITY CONTROL IN ORDER TO POSSESS OR USE A FIREARM. THIS IS A FEDERAL AND STATE LAW.

**RULE #4** YOU SHALL NOTIFY YOUR PROBATION OFFICER WITHIN TWENTY-FOUR (24) HOURS AFTER BEING ARRESTED, STOPPED OR QUESTIONED BY ANY LAW ENFORCEMENT OFFICER OR GOVERNMENTAL AGENCY.

**RULE #5** YOU SHALL NOT ASSOCIATE WITH ANYONE ON COMMUNITY CONTROL OR PAROLE OR ANYONE WHO HAS BEEN CONVICTED OF A FELONY, OR PERSONS WHO ENGAGE IN CRIMINAL ACTIVITY.

**RULE #6** YOU ARE **NOT** PERMITTED TO PURCHASE, POSSESS, USE, OR HAVE UNDER YOUR CONTROL, ANY CONTROLLED SUBSTANCES, DRUG PARAPHERNALIA, EXCEPT AS SPECIFICALLY PRESCRIBED **TO YOU** BY A LICENSED PHYSICIAN. YOU ARE NOT PERMITTED TO FREQUENT PLACES WHERE CONTROLLED SUBSTANCES ARE ILLEGALLY SOLD, DISTRIBUTED OR ADMINISTERED. WHEN DIRECTED BY YOUR PROBATION OFFICER, YOU WILL BE REQUIRED TO SUBMIT TO WHATEVER TYPE OF TEST YOUR PROBATION OFFICER FEELS IS NECESSARY TO ENFORCE THIS RULE. YOU WILL PAY THE COST OF ALL DRUG/ALCOHOL TESTING. DEFENDANT WILL NOT ALTER DRUG TESTS IN ANY WAY.

**RULE #7** YOU SHALL REFRAIN FROM THE USE/POSSESSION OF ALCOHOL, AND NOT FREQUENT BARS OR TAVERNS.

**RULE #8** YOU ARE NOT PERMITTED TO USE ANY OTHER FORM OF INTOXICANTS.

**RULE #9** YOU WILL NOT BE PERMITTED TO BUY, OWN OR OPERATE ANY MOTOR VEHICLE UNTIL YOU OBTAIN PERMISSION OF YOUR PROBATION OFFICER. IF PERMITTED TO OPERATE A MOTOR VEHICLE, YOU WILL HAVE A VALID OPERATOR'S LICENSE AND WILL PROVIDE YOUR PROBATION OFFICER WITH PROOF OF INSURANCE.

**RULE #10** YOU SHALL KEEP TWO APPOINTMENTS A MONTH WITH YOUR PROBATION OFFICER UNLESS OTHERWISE DIRECTED.

**RULE #11** YOU SHALL MAKE A MONTHLY PAYMENT OF \$\_\_\_\_\_ TOWARDS COURT COSTS, RESTITUTION, FINES AND FEES.

**RULE #12** DURING THE TERM OF YOUR COMMUNITY CONTROL, YOU SHALL ANSWER ALL INQUIRIES FROM YOUR PROBATION OFFICER TRUTHFULLY.

**RULE #13** THE DEFENDANT SHALL NOT ENTER IN ANY AGREEMENT TO ACT AS AN INFORMER OR A SPECIAL AGENT OF A LAW ENFORCEMENT AGENCY WITHOUT THE PERMISSION OF THE COURT.

**RULE #14** I WILL AT NO TIME HAVE ANY CONTACT WITH THE VICTIM(S) OF MY CRIMES (DIRECTLY OR INDIRECTLY).

- **Reporting Instructions**

- **Use of Cell Phones:** While in the Probation Department we ask that you silence your cell phones and cease all conversations.
- **Family and Friends:** While there is a waiting area available, space is limited. We ask that all family and friends wait for you in the upstairs corridor or in their vehicle.
- **Children:** Due to the wide range of offenders that report to the Adult Probation Department, **children are not permitted** in the offices or waiting areas of the department. This policy is for the safety of the child. If you have child care issues, consult with your supervising officer to make arrangements.
- **Appropriate Dress:** It is expected that individuals reporting to the Adult Probation Department be dressed appropriately. Do not wear clothing depicting or advertising alcohol or drug consumption, foul language or other content that may be offensive to the general public. You will be asked to go home and change if you are deemed in violation of this instruction.
- **Search and Seizure:** As referenced in your Rules and Conditions of Community Control, you are subject to warrantless search of your person, residence and motor vehicle at any time. Realize that you may be searched upon reporting to the Adult Probation Department and that any illegal contraband may be seized and result in your arrest.
- **Contraband:** You are to have no form of contraband on or around your person when reporting to the Adult Probation Department. Examples of contraband would include:
  - Any illegal substance or material
  - Drug paraphernalia
  - Weapons, ammunition or dangerous ordinances (knives, blades, etc.)Found contraband will be seized and may result in your arrest, filing of a violation and/or filing of new charges.
- **Drug Testing:** Upon reporting to the Adult Probation Department you may drug tested per the rules and conditions of your community control. Even if the court did not order random drug testing, an officer can test you based on reasonable suspicion of use. Any attempt to alter a urine sample may result in the filing of a formal violation of your community control and you may be taken into custody immediately. You must pay all costs associated with drug testing.
